This press release relays the information contained in the notifications received by Distrigas from, respectively, Suez-Tractebel SA, GDF SUEZ SA and Publigaz SCRL (shareholding as at 1st September, transitional provision) and Eni S.p.A., Eni Gas & Power Belgium SA and Publigaz SCRL respectively (situation on 30 October 2008).

Eni S.p.A. holds directly and indirectly 100% of the capital of Eni Gas & Power Belgium SA. No individual or legal entity has ultimate control of Eni S.p.A. Eni Gas & Power Belgium SA is acting in concert with Publigaz SCRL. No individual or legal entity has ultimate control of Publigaz SCRL.

Comments:

Eni Gas & Power Belgium SA and Publigaz SCRL are acting in concert in the context of a shareholder pact aimed at pursuing a long-term common policy for Distrigas that came into force on 30-10-2008, the date on which Eni Gas & Power Belgium SA acquired 57.24% of the shares in Distrigas SA from Suez-Tractebel SA.

The action in concert between Suez-Tractebel SA and Publigaz SCRL aimed at pursuing a long-term common policy for Distrigas ended on 30-10-2008 following the transfer of 57.24% of shares in Distrigas SA by Suez-Tractebel SA to Eni Gas & Power Belgium SA.
